General Information

Plot Information and Identification

The garden plots are located on McDonough Street (across from Inwood Golf Course). Plots will be staked and ready for planting at the earliest possible date, with consideration to weather and soil conditions. Garden plots are identified with a permanent numbered wooden sign placed in the left corner of each plot.

* To receive resident discount rates, you must bring your Resident Discount Card. To obtain a Resident Discount Card you must prove Joliet residency with (1) form of picture I.D. (in addition to RDC), and a current property tax or utility bill showing your name and address.

Organic Reminders

The use of synthetic or chemical pesticides, fungicides, and herbicides is not permitted in the garden. Park District personnel will not use these chemicals either, but will continue with an appropriate level of maintenance.

ADA Raised Garden Plots

ADA raised garden plots will be offered to individuals with special needs. Please indicate on your registration form if you are requesting a raised garden plot due to special needs. The half-size plot fees also apply to raised plots.

Maintenance

Our garden is on land that has been lent to us by the State of Illinois and the Joliet Park District. Understand that this is a community garden and in order for it to succeed, gardener support is needed to maintain the site, manage compost, and help keep pathways clear of debris and weeds.

Parking

Shared parking is located at the River Valley Justice Center, 3200 W. McDonough Street. Street parking and parking in any grassy area is strictly prohibited and can result in a ticket.

Organic Gardener Guidelines for 2018

The following guidelines have been established by the Joliet Park District. The Park District requests that gardeners assume certain responsibilities for their plot(s). Please read the guidelines and direct any questions to Katie Zaban at 815.741.7277 ext. 601 or kzaban@jolietpark.org.

1. All gardeners are required to complete an application form. The application fee is due at registration. To qualify for resident discount rates, you must bring your Resident Discount Card. To obtain a Resident Discount Card you must prove Joliet residency with (1) form of picture I.D. (in addition to RDC), and a current property tax or utility bill showing your name and address.
2. Gardening classes and events are scheduled from January through October. Monthly garden classes are scheduled for the third Thursday of every month from 6 – 7 pm.
3. All plots must be planted by June 1. The Park District may reassign unplanted plots, without refund, after this date.
4. Before planting, check the numbered stake to be certain you are in the correct plot. If you are unsure of your plot number, contact Katie at 815.741.7277 ext. 601 or kzaban@jolietpark.org before planting.
5. Street parking is prohibited and can result in a ticket. Shared parking is located at the River Valley Justice Center, 3200 W. McDonough Street.
6. All gardeners are responsible for keeping pathways around their plot clear and weed free.
7. For ease of hose use, plot pathways must remain intact, even with adjacent plots. Removal of pathways is prohibited.
8. **Weed Policy and Consequences** Participating in a community garden affords you an opportunity and a responsibility to your fellow gardeners. In order to ensure good gardening practices, plots must be reasonably maintained. Reasonably maintained means weeds under control (less than 6" tall) and plants regularly cared for, watered and harvested. Plants must not exceed plot boundaries. The Park District has the right to mow the entire plot if the plot is not maintained after a warning is issued. Gardeners will have one week to weed before the plot is mowed.

Weeds compete with other plants in your garden and can quickly become invasive. If weeds are left to go to seed they will affect your neighbor's garden as well. Gardeners are responsible for keeping their plot weed free.

9. Trees are not allowed to be planted.

10. Plant tall plants and vines within the boundaries of your plot where they will not interfere with your neighbor's plot.
11. Pick up and dispose of litter.
12. Put weeds and dead plants from your garden plot into the compost bins provided. No plant material should be brought in by outside sources. Do not leave weeds or other debris in the pathway.
13. Each person is responsible for only their plot(s) and surrounding pathways. Do not apply anything to, or pick from another person's plot without his/her express approval.
14. Unattended watering is not permitted. Make sure all faucets are off and hoses are disconnected when leaving the garden.
15. The following are not permitted: planting of illegal plants; smoking and chewing tobacco (tobacco can transmit a virus to plants and cigarette butts are loaded with toxins) pets, drugs, alcohol, radios, boom boxes and fires.
16. Children should not be unattended in the garden.
17. For your safety, only garden during daylight hours.
18. Report theft, vandalism and unusual activities to Katie at 815.741.7277 ext. 601.
19. The Joliet Park District is not responsible for: costs related to individual garden plots, theft, damage, vandalism or any other acts of destruction or loss. The Park District makes no guarantees for water drainage, growth, or drought.
20. At the end of the gardening season, all dead plants and non-plant materials must be removed and disposed of properly whether you are returning or not. All gardens should be left neat and tidy. If your garden is not cleaned up by November 2, you could lose your gardening privileges for the next season. ***Will County Master Gardeners Gleaning Project:*** If you are done with your harvest, but your garden is still productive, please consider allowing the Will County Master Gardeners, with the children of Hartman Center, to continue to harvest the plot and then donate it to charity. Gleaning markers (either a flag or stone) are available at the garden in mid-August. If you would like to participate, put the flag/stone in your plot. The Gleaning Project will end the second week of October. You are still responsible for completely cleaning up your plot by November 2.
21. If you plan to discontinue the use of your garden space at any time during the growing season, let us know as soon as possible so your plot can be reassigned.
22. Use common courtesy, be considerate of your gardening neighbors and enjoy!
23. Violation of gardener guidelines: If any of the guidelines are violated, you will be contacted by phone, e-mail and/or U.S. mail. You will then have one week to address the violation. After one week, if the violation has not been remedied, you may lose your gardening privileges.
