Notice is hereby given that Joliet Park District is accepting sealed bids for **Barber & Oberwortmann Horticulture Center Ceiling Installation**. Project address: 227 N. Gougar Rd, Joliet, IL 60432

Project includes ceiling material and installation for approximately 5,476 sq. ft., which includes: banquet room, lobby and gallery. Including but not limited to installation of drop ceiling, framing, drywall, and crown/trim for decorative ceiling. The contractor is required to take measurements before bidding. Any equivalent, substitute material must be approved. Pre bid site visit recommended and available upon request. Tentative project completion date is December 20, 2024.

The Joliet Park District Board of Park Commissioners reserves the right to waive all technicalities, to accept or reject any or all bids, to accept only portions of a proposal and reject the remainder without disclosure for any reason. Failure to make such a disclosure will not result in accrual of any right, claim or cause of action by any Bidder against the Joliet Park District.

Bids shall not include federal excise tax or state sales tax for materials and equipment to be incorporated in, or fully consumed in the performance of, the work. An Exemption Certificate will be furnished by the Joliet Park District on request of the Bidder, for use in connection with this project only.

The Work of this Project is subject to the Illinois Prevailing Wage Act, 820 ILCS 130/0.01 et seq. A prevailing wage determination has been made by the Illinois Department of Labor for public works projects in Will County. The Contract entered into for the Work will be drawn in compliance with said law and proposals should be prepared accordingly and provide for payment of all laborers, workmen, and mechanics needed to perform the Work at no less than the prevailing rate of wages (or the prevailing rate for legal holiday and overtime work) for each craft, type of worker, or mechanic.

All bid proposals must be accompanied by a bid bond or bank cashier's check payable to the Joliet Park District for ten percent (10%) of the amount of the bid as provided in the Instructions to Bidders. No proposals or bids will be considered unless accompanied by such bond or check.

The Contractor selected will also be required to comply with all applicable federal, state and local laws, rules, regulations and executive orders including but not limited to those pertaining to equal employment opportunity.
